
Dr. Mark Hixon –

"Ten Coming Changes in Oregon's Ocean: the Usual, the Inevitable, and the Insidious"

Wednesday, November 7, 7:00 to 9:00 PM Corvallis-Benton County Public Library 645 NW Monroe Avenue

We are pleased to have Dr. Mark Hixon once more present his insights into Oregon's coastal concerns, including such topics as invasive species, tsunamis, and ocean warming.

Dr. Hixon is professor of Marine Ecology and Conservation Biology in Oregon State University's Department of Zoology. His expertise is the ecology of coastal



marine ecosystems, and he focuses on what naturally regulates populations and sustains biodiversity. He recently co-chaired a stateappointed committee that designed the new marine reserve and protected areas off Cape Perpetua.

This evening is a good warm-up to League's December consensus on "Coastal and Nearshore Oregon." Throughout the presentation keep League's consensus questions in mind—they're included with this Bulletin.

The Coastal Zone in Oregon is a watershed-based area as it was defined by the Oregon Legislature in 1971 and again in 1973. The Oregon Coastal Management Program applies to all land and water areas within this zone, except lands owned by the federal government or those held in trust under Indian tribal jurisdictions; it is structured around all watersheds in Oregon that drain to the Pacific Ocean.

Lastly, I hope some of you may yet have time to attend the Nov. 1 and 2 Woman Citizen Symposium at OSU, cosponsored by our League.

Creekside Center Development

**We have been waiting** since late June 2011 for the developer of Creekside

Center to respond to the remand issued by the Land Use Board of Appeals (LUBA).

I'm sure you all remember that the Corvallis League appealed the City's approval of this neighborhood shopping center development at 53rd St and Philomath Boulevard to

LUBA because it seriously encroached on a highly significant wetland designated by the City for protection.

The applicant has now submitted a revised application, but at our bulletin's press time, the formal letter requesting a public hearing has not been received. The City's time deadline doesn't start until receipt of this letter. Stay tuned.
