# **COMMUNITY CHOICE ENERGY: Should Oregon Communities** Have a Choice?

Community Choice Aggregation (CCA), also known as Community Choice Energy, is an alternative to investor-owned utility energy supply systems such as Pacific Power. When a community participates in the CCA model, the utility continues to deliver power, maintain the grid, and provide billing and other customer services. But costs are lower for consumers and consumers have greater control of their energy sources, generally more sustainable options such as solar.

- Community Choice Energy operates in eight states so far California, Illinois, Massachusetts, New Jersey, New York, Ohio, Rhode Island, and Virginia. What has their experience been?
- What are the benefits and challenges of becoming a CCA community?
- Is Oregon ready for Community Choice Energy?

Our November program will explore these questions with the help of our presenters:

Alan Hickenbottom represents LEAN Energy US, a California-based non-profit that provides information resources and market expertise to a national network of local governments, commercial and non-profit organizations, advocacy groups and individuals wishing to pursue CCA in their states and/or communities.

Janice Thompson is on the staff of the Oregon Citizens' Utility Board, which was created in 1984 by ballot initiative to advocate on behalf of and to protect the rights of the residential and small business customers of investor-owned utilities in Oregon.

# Housing Committee Report

The Housing Committee is very active in its role as advocate for affordable housing. For

us the term "affordable housing" covers the range from sheltering our homeless population to providing affordable work force housing to supporting senior housing. Each time a person or family who works in Corvallis makes the financial decision to buy or rent a home outside of the city, our community loses. We lose property dollars, support for our local businesses, loss of school support dollars, and as important but perhaps less tangible, we lose community engagement and diversity. What we gain is increased traffic and increased pollution. Affordable housing benefits us all.

This month, Housing Committee member Sara Ingle testified before City Council in support of the South Corvallis Urban

Renewal Plan. Our committee sent the Corvallis Gazette Times a letter in support of measure 102 which "Removes restrictions that affordable housing funded by municipal bonds be government owned."

Committee member Lynn Jarvis has agreed to be the Housing Committee's representative to the Corvallis Sustainability Coalition's - Opportunity Village project.

All of our committee rues the loss of Judy Ball who has moved to West Virginia to return to her roots. The committee is seeking new members. If our work interests you, please consider attending a meeting or two.

# Climate Change Report

 Our Children's Trust 'Juliana v United States' was scheduled to start in Federal Court (Eugene, Oregon District) Monday, October 29.

On Oct 19, Supreme Court Chief Justice Roberts approved what some folks consider a temporary stay. Plaintiffs said they are prepared to go to trial as scheduled.

It may be delayed or the historical case could be dismissed. LWVUS and LWVOR jointly have two amicus briefs and LWV is clearly a "friend of the court." Let me know if you would like to carpool to Eugene if the case is rescheduled for after the elections. An event/rally was planned for Monday, October 29 in Eugene with a number of League members there with the LWV Oregon Climate Change banner.


2) LWVOR Climate Change October 8th Update. Clean Energy Jobs (Cap and Invest) Legislation & Joint Committee on Carbon Reduction. League Action members Julie Chapman and Claudia Keith attended Renew Oregon's Clean Energy Jobs (CEJ) mini lobby day in the Capital on Sept 25th. We visited six Legislator leaders and provided each a written follow-up. We also attended the Legislative Joint Committee on Carbon Reduction public hearing. This meeting had a number of invited guests, including a person who works at the Heritage Foundation. LWVOR has joined over 40 organizations and endorsed the 9/25 Clean Energy Jobs coalition's policy outcomes statement.

A first hint of Climate Change risks was at the Oregon Office of Economic Analysis (OEA) committee slide presentation in late August to House and Senate Revenue/Finance Committees. The detailed OEA report included the following: "...there is a reasonable expectation that migration flows will continue to be strong as the rest of the country becomes less habitable over time."

#### In 2019 there may be legislation addressing:

- Sustainable investing Oregon Treasurer, Tobias Read, thru his leadership, SEC urged by institutions to mandate ESG disclosure via Recent Oregon Sustainable Summit. You can learn more about how Oregon Treasury takes action as a responsible investor in the Treasurer's annual Stewardship Report;
- Governor Kate Brown's intent to challenge any federal rollback of air, water and other safety standards;
- Oil rail safety, fracking and improved energy efficient building codes to complement the recent Governors executive order which charts course for net zero buildings; and
- Community Choice Aggregation (CCA) program movements. A number of Oregon cities are currently reviewing this program to improve their Climate Action Plan outcomes.
- 3) LWVUS will send six members to UN COP24 (Conference of the Parties to the *United Nations* Framework Convention on Climate Change) as observers in Katowice, Poland in early December 2018. This COP will address the most recent UN's Intergovernmental Panel on Climate Change (IPCC) 1.5 degrees C. # A good read in preparation for LWV 100<sup>th</sup> anniversary

The LWVUS 2018 Convention keynote speaker was Elaine Weiss, author of *The Women's Hour: The Great Fight to Win the Vote.* The book is told through the eyes of those who supported and opposed women's right to vote and prominently features LWV founder, Carrie Chapman Catt. "Nashville, August 1920. Thirty-five states have ratified the Nineteenth Amendment, twelve have rejected or refused to vote, and one last state is needed. It all comes down to Tennessee, the moment of truth for the suffragists, after a seven-decade crusade. The opposing forces include politicians with careers at stake, liquor companies, railroad magnates, and a lot of racists who don't want black women voting. And then there are the "Antis"--women who oppose their own enfranchisement, fearing suffrage will bring about the moral collapse of the nation."

The League, after studying an issue, does give testimony. Below we share with you the testimony given on the South Corvallis Urban Renewal Draft Plan and Report on October 15, 2018:

To: Mayor Traber and Members of the Corvallis City Council

From: League of Women Voters of Corvallis, Laura Lahm Evenson, President

Re: South Corvallis Urban Renewal Draft Plan and Report

The LWV of Corvallis believes in comprehensive, citizen-based land use planning that maintains and enhances community livability and protects resource lands by:

- preventing urban sprawl
- concentrating development within urban areas
- efficient use of land as a resource
- integrating multi-modal transportation planning and implementation
- providing a variety, range and mix of housing
- allowing a range of land uses
- developing high equality public areas and open space
- delivery of high quality public services in an orderly and economic manner
- assuring citizen participation

Based on this position and, after studying the South Corvallis Urban Renewal Draft Plan with Accompanying Report, we would like to state our support for this Urban Renewal project and the draft plan as presented.

While we did not confirm all the financial assumptions and computations, we feel that it is a well thought out and comprehensive plan. We believe it will accomplish many of the goals of the South Corvallis Area Refinement Plan adopted in 1997. We are encouraged that the taxing districts affected appear to be supportive of the plan and that the community has been actively engaged.

We are hopeful that some of the High Density Housing needs required by the State will be placed within this URD.

The ability to create affordable housing opportunities, promote residential and commercial development projects, create transportation and pedestrian improvements, restore the Millrace, and adequately fund the administration of the Plan, lead us to believe this will be a successful project which will enhance South Corvallis.
